

RESOLUTION NO. 04-12**PERTAINING TO THE ESTABLISHMENT OF A UTILITY PERMIT FEE FOR UTILITY INSTALLATIONS WITHIN THE COUNTY RIGHT-OF-WAYS.**

WHEREAS, pursuant to the authority granted in Article 25 of the Annotated Code of Maryland, the Board of County Commissioners of Calvert County, Maryland has general authority to promulgate, amend and repeal rules and regulations governing the construction and repair of all public roads, other than state or federal highways, within Calvert County; and,

WHEREAS, effective the 12th day of October 1976, the Board of County Commissioners adopted the Calvert County Road Ordinance, as amended from time to time; and,

WHEREAS, pursuant to the authority granted in Article 25, §11(b)(7) of the Annotated Code of Maryland, the Board of County Commissioners of Calvert County also has authority to establish fees to defray the cost of reviewing plans and performing inspections for the construction of roads and for utility cuts; and,

WHEREAS, it is the desire of the Board of County Commissioners of Calvert County to establish a utility permit fee for the issuance of permits within the County right-of-ways, (along, over and under), by the Department of Public Works of Calvert County, to cover the cost of providing this service; and,

WHEREAS, after due notice was published, a public hearing was held by the Board of County Commissioners on January 24, 2012, at which time public comment was solicited and at which time the Board made a determination of what changes would be implemented.

NOW, THEREFORE BE IT RESOLVED, by the Board of County Commissioners of Calvert County, Maryland, that a utility permit fee of \$240.00 is established for the issuance of permits within the County right-of-ways, (along, over and under), by the Department of Public Works of Calvert County.


