Special Bulk Pickup Items

The Calvert County Division of Solid Waste offers county citizens free bulk item pickup services. This service is for large items that cannot fit into a standard sized sedan. There is a limit of three items per pickup. Each residential address is limited to two pickups per year. Indoor furniture, mattresses and large indoor appliances are the only items eligible for pickup. Call 410-326-0210 or visit www.calvertcountymd.gov/recycle to schedule an appointment. A refrigerant appliance pickup requires a pre-paid fee of \$10 by cash or check. Prior to the scheduled pickup date, items must be placed at the end of your driveway of property (curb) line, where private property meets a public road. Staff cannot go on private roads or private property to get items.

The following are some examples of items that **cannot** be picked up:

- Building/construction materials
- Farm equipment
- Televisions/electronics
- Pianos/musical instruments
- Outdoor furniture/picnic tables
- Carpet/padding
- Heat pumps
- Play equipment/toys
- Exercise and recreational equipment
- Lawnmowers
- Pool/game tables
- Tractors/tillers
- Cooking grills

Syringes and Lancets

Syringes and lancets should be disposed of in a specially designed “SHARP” container. Please do not place them in a regular recyclable container. Needles and lancets from home health care may be disposed of in the normal household trash once placed in a “SHARP” container.

Calvert County Residents

No Cost Disposal Items

- Household bagged trash
- Recyclables (except for yard debris, tires, refrigerant appliances, masonry materials, propane tanks and gas cylinders)
- Furniture (Appeal Landfill only)
- Pet animal waste
- Propane tanks (1 lb. size only)
- Helium tanks (up to 20 pounds)
- Non-refrigerant appliances: such as stoves, washers, dryers, dishwashers and microwaves
- Metal: including heaters, pipes, plumbing, sheet metal, ducts, fencing, metal septic tanks, tubs, sinks, etc.
- Durable medical equipment
- Lead-acid batteries
- Household sharps in an appropriate container

Chargeable Items

- Construction and demolition material: wood, sheetrock, sinks, toilets, tubs, siding, tile, vinyl and wood flooring, carpet, padding, insulation, roofing materials, kitchen/bathroom cabinets, counter tops, windows, doors, masonry materials
- Dirt and soils
- Bulk trash: docks, pier pilings, landscape timbers and telephone poles
- Yard debris: leaves, branches, tree trunks, shrubs and stumps
- Refrigerant appliance (per item; includes refrigerators, freezers, air conditioners and dehumidifiers)
- Animal carcasses
- Boats: wood and fiberglass (remove fuel tanks, oil, batteries and motors)
- Tires: all car, truck, off-road and other tires on or off rims

Calvert County Commercial Customers

Applies to commercial haulers, commercial businesses and business self-haulers

No Cost Disposal Items

- Non-refrigerant appliances: such as stoves, washers, dryers, dishwashers and microwaves
- Metal: including heaters, pipes, plumbing, sheet metal, ducts, fencing, metal septic tanks, tubs, sinks, etc.
